

Market 32 Tenth Anniversary 9/7/25 Sweepstakes Official Rules

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility

Market 32 Tenth Anniversary 9/7/25 Sweepstakes (the "Sweepstakes") is open only to legal residents of Connecticut, Massachusetts, New Hampshire, New York, Pennsylvania and Vermont who are at least eighteen (18) years old at the time of entry. Void where prohibited. Proof of residency and age may be required. Void where prohibited. 4. How to Enter

To enter the sweepstakes, you must have a Price Chopper AdvantEdge Card. If you do not have an AdvantEdge Card, you may obtain one for free at any participating store location or online at <https://www.pricechopper.com/rewards/apply/>. Registering is free. Once you have an AdvantEdge Card, you may enter once per calendar week by scanning at an eCoupons kiosk in any Price Chopper, Market 32 or Market Bistro location (excluding the Price Chopper located at 49 Amherst St. in Lake George, NY) to be entered for the respective drawing of that calendar week.

LIMIT: You may receive one (1) entry per calendar week for the drawing for that calendar week by scanning your AdvantEdge Card at any eCoupons kiosk in any participating location. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different AdvantEdge Cards, email addresses, identities, registrations and logins, or any other methods will void that entrant's sweepstakes entries and that entrant may be disqualified. - Monday, November 17, 2025 (based on entries for Sunday, November 9, 2025 - Saturday, November 15, 2025)

The potential winner(s) will be contacted using the email address provided with the registration or on file with the Sponsor and may be awarded the prize subject to verification of eligibility and compliance with the terms of these Official Rules. The potential winners will be notified by email on or about two days after the drawing. Failure by a potential winner to respond to any contact within five (5) days of notification will result in disqualification, and Administrator will select an alternate potential winner in the same manner. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder. Odds of winning depend on the number of eligible entries received during the Sweepstakes Entry Period.
